I hereby certify I am in good health, and I have trained to run the distance of the race that I am entering (8k). I assume all risks associated with running in this event, including, but not limited to, falls, contacts with other participants, the effects of the weather, including high heat and/or humidity, conditions of the trails/roads, all such risks being known and appreciated by me. Having read this waiver and knowing these facts and in consideration of your accepting my entry, I, for myself and anyone entitled to act in my behalf, waive and release U.S.A. Track and Field (USATF), BTO Multisports, Captain Jack's Triathlon Club, Everyday Athlete, the City of Kirkland and all sponsors, their representatives, all race staff, all race volunteers, any other persons assisting with the race, and their successors from all claims or liabilities of any kind arising out of my participation in the race even though the liability may arise out of negligence or carelessness on the part of the persons named in this waiver. I grant permission to all of the foregoing to use any photographs, motion pictures, recordings, or any other record of this for any legitimate purpose. I understand that if the race cannot be held on April 15, 2012 due to circumstances beyond the control of the race committee and sponsors, including, but not limited to, unsafe weather conditions or governmental ban, the race will be cancelled and will not be rescheduled for another date this year. Since the majority of event costs (permits, advertising, etc.) occur prior to the race, my entry fee will not be refunded.
